Benefits and recommendations



EasyLin 100-50 NPN is recommended for dairy cows and fattening bulls (from 300 kg liveweight) with 0,5 - 1,4 kg per animal and day for additional feeding of omega-3 fatty acids. Urea shall only be fed to animals with a functional with a functional rumen. Therefore EasyLin 100/50/NPN should be fed up to a maximum of 200 g per 100 kg of live weight. Feeding urea to the maximum level dose should be done gradually. The highest dosage should be given with a feed which is rich in easy digestible carbohydrates and poor in soluble nitrogen. Maximum of 30 % of the total nitrogen in the daily ration should come from urea nitrogen. Free from genetically modified organism (Non-GMO).
